

TERMS & CONDITIONS - MONEY WEEK

To be endorsed as an official Money Week event, you will need to complete the registration process and comply with the following Terms and Conditions:

YOUR EVENT MUST:

Take place during Money Week (14 – 20 August 2017)

Be a community event and not a commercial venture. Money Week events are not intended to be profit making activities. Charges to attend Money Week events must be nominal, covering event running costs only e.g. venue hire or speaker fee.

All Money Week events must be accessible and any event charges clearly publicised to participants.

Welcome involvement from everyone in the community, or your workplace or school community who wishes to participate.

ANY INFORMATION YOU PROVIDE TO PARTICIPANTS MUST:

Meet the objectives of Money Week to encourage New Zealanders to take positive action regarding their personal finances.

Ensure that any financial information delivered is accurate, balanced and up-to-date and complies with industry rules and regulations.

Contain no overt or covert promotion, sales pitches, or bias favouring particular commercial products or services.

Provide general financial education and not contain product marketing material.

YOUR ORGANISATION MUST:

Use the Money Week 2017 logo and any other relevant digital assets to promote the event in accordance with the branding guidelines. When using the logo, you must adhere to the specific guidelines so Money Week as a brand is represented in a consistent and professional manner. The Money Week logo includes the Commission for Financial Capability logo. Failure to include this aspect is not allowed as it is a modification to the original logo. These guidelines are available on the Money Week website.

Agree to provide text and photographs of your event for the Money Week website, and for media releases.

Complete a short evaluation form that will help measure participation in, and potential outcomes of, your event and Money Week overall.

Agree to these Terms and Conditions if you are to refer to Money Week in any way.

PRIVACY

The collection of information for the purposes of promoting and supporting Money Week is bound by the Privacy Act 1993 and the information privacy principles which are set out in the Act. Under the Privacy Act, information provided by individuals interested in becoming involved in Money Week 2017, including name and address and contact details, can be used by Money Week as part of coordination of the event.

Your agreement to these Terms and Conditions allows information in your registration to be used for the purpose of promoting and coordinating the Money Week 2017 event and any future promotion of Money Week.

Your information will not be disclosed to commercial users of information.

You have a right of access to your personal information and you may request us to provide such access. We will process your access request promptly. We may ask you to verify your right to receive the personal information requested.

Money Week reserves the right to suggest modification(s) or not give approval to any proposed activities or events that do not comply with the Money Week Terms and Conditions.
